Flexible PVC is a complex material made from different substances (PVC resins, plasticizers and additives) conferring its specifics properties. The substances allowing its extra suppleness are plasticizers. A lot of different plasticizers are available, but about 80% of the worldwide consumption is comprised of three plasticizers: di-2-ethylhexyl phthalate (DEHP) also referred as di-octyl phthalate (DOP), di-isononyl phthalate (DINP) and di-isodecyl phthalate (DIDP). Those plasticizers, present in high quantity in flexible PVC strips and sheets (30 to 45% w.t.), have very different impacts on human health and environment.
