Product Description

Latched Single Horizontal Sliding Cold Room Fire Door "SKSDFP60"

Door leaf is constructed with 1.00mm thick mild steel sheet with ceramic fibreboards and polyurethane boards as infill material. Three-sided sliding system is constructed with a 2.00mm thick stainless steel sheet with a jamb depth of 90mm. For assembly on masonry supporting walls.

Tested Sizes: Single leaf door: $2884/2820 \times 3150 \times 170 \text{ mm} (\text{w x h x t})$ Single leaf door frame: $2894 \times 3040 \text{ mm} \times 40 (\text{w x h x t})$

Limitations: Door surface can be coated with rigid PVC with maximum thickness of 200 microns.

Fire Ratings

The product noted above has been evaluated according to the requirements of the standard UL 10B and has qualified for up to **60 minutes** (1 hour) fire rating.
